Purpose:

This adoption will eliminate the fingerprint requirement for business principals where there is a change in motor vehicle dealer business structure or ownership. This change will streamline the application process without compromising public protection, because the department is able to identify and qualify applicants through other means. Motor vehicle dealers reporting a change in business structure or ownership will avoid the time and expense required to get and submit fingerprint cards for new principals, corporate officers, directors, managing partners, members or trustees.

In addition the amendment replaces outdated wording "and legal and financial history" with the words "a personal and criminal history statement." The intent is to use the same words in rule as are used to describe the form used by the department
