Fuel Carrier Schedule Instructions

Use this form to show the fuel transported as listed on your Fuel Carrier Report. Fill out separate schedules for each: Schedule Type, Product Code, or Jurisdiction.

Company Name and FEIN: The legal name associated with the Federal Employers Identification Number (FEIN) listed on the Fuel Carrier Registration.

Account Number: The 9-digit alpha-numeric number listed on your license.

Reporting Period: Time period relating to the tax return, month and year.

Schedule Type (enter one type):

14A Gallons received at a Washington terminal, refinery storage, or bulk plant and delivered to another jurisdiction.

14B Gallons received at an out-of-state terminal or bulk plant and delivered in Washington

14C Gallons received at a Washington terminal or bulk plant and delivered in Washington

Product Code: A code identifying the fuel type (only one per schedule) see Compliance Guide. A list of codes can be found at www.dol.wa.gov.

Mode: Mode of transport using one of the following:
J = Truck **R** = Rail **S** = Ship **B** = Barge **PL** = Pipeline

Rail Car Number and Vessel ID: If transported by rail, include rail car number; if transported by vessel include the vessel identification

Origin: Location where fuel was *removed*. If removed from a terminal, use the terminal code. A list of codes can be found at http://www.irs.gov/pub/irs-utl/tcn_db.pdf.

Destination: Location where the fuel was *delivered*. If delivered to a terminal, use the terminal code.

Document Number: A document listing and acknowledging receipt of goods for shipment, such as Bill of Lading (BOL) or weigh bill.
