The complainant had pre-purchased and earn and arranged for her cremated remains to be placed on her son's grave in 2017.

The respondent cemetery claimed that did not have a record of the urn purchase and were unable to order the urn selected in 2017. Complainant was upset when she finally received a 50% refund for the urn from the respondent. The complaint also claimed the respondent staff refused to give contact information for the main office.

Complainant's friend passed in March of 2020 and was cremated.

The respondent was unable to verify the 2017 purchase of the earn, though investigation would eventually produce trust statements verifying the urn purchase.

The complainant faxed copies of the 2017 cemetery paperwork to the Respondent cemetery on May 6, 2020. Responded staff continue to argue with the complainant about the urn. The complainant asked for the contact information for the owner or supervisor, but respondent ttaff refused to provide any information. Complainant ultimately filed a complaint with the Department of Licensing, which led to the respondent finally refunding the full amount for the urn.

Complainant's mother passed on June 30th, 2019, and was entombed in the mausoleum, along with the cremated remains of her husband, who died in 2012. The name bars, photo, and base were purchased in 2019. The cemetery failed to place the name bars, photos and based on the crypt plate, over a year after placement of remains in the crypt.

Facts of the case are the complainant contacted the respondent in August of 2018 for an update on the name bars and military plaque to be placed on her parents crypt.

Complainant was out of state from December 19 until early March 2020. When the complainant went to the cemetery in March 2020, there was nothing on the trip plate.

The cemetery office was closed due to COVID-19 and the complainant was unable to leave a voice message on the cemetery's telephone as the cemetery did not have a voicemail system set up.

April 2020 the complainant visited the cemetery and saw the respondent staff of record walking cemetery grounds with another staff member. Complainant asked about the status of the name bars. The respondent staff did not recall talking with the complainant in August of 2019 about the crypt memorialization. Responded staff did confirm the photo and bases were ready to be installed and said everything would be installed by Memorial Day. Responded staff also asked the complainant to send all the information and cemetery receipts because the cemetery's records were incomplete.

Complainant received a message later on the same day that only the photo in base could be installed by Memorial Day as the name bars had to be reordered.

On May 1st 2020, the responded visited the cemetery and found her parents photo had been installed on the wrong crypt. Complainant complained to the cemetery and the photo was reinstalled on the correct crypt.
