Because there's different states have different requirements and the training not everyone's going to have the MSL, so they've they've updated that, at least the army portion for the regulations saying hey, if it's a state derived curriculum or two or three, you need to have that umm you know include all that other stuff but yeah.

Recently we completed the data sharing agreement with other agencies in the state to give us a full access to all of the information in the crash report, not just location and type of vehicle et cetera, but also.

Driver's license numbers and addresses, and the the full report is is at our disposal now.

Our data, our data analysts will then take that information and and combine it with data in the Department of Licensing Systems, which will create a more comprehensive data set.

It lets us look at everything for these writers, as you'll as you'd imagine.

That's quite a bit of information.

Our most complete data set currently is 2017 to 2021.

I'm gonna present some more a a more in depth of version of of a look at 2017 to 21 after I give you an overview of the 2022 fatal crash statistics for motorcyclists.

This is the these are the.

Let me get my mouth back in gear.

Uh, these are the statistics for 2022.

Uh, in in 2022, the in the state of Washington motorcyclist make up approximately 70 or corrections 7% of all licensed drivers and only 3% of registered vehicles are motorcycles.

However, and much more sobering to me is the fact that motorcycles accounted for only 1.8% of all vehicle related crashes, but made up 17% of fatal crashes from 2017 to 21.

Uh, the statistics that you'll see on your screen right now show that in 2022 there were 657 serious injury or fatal injury or fatal crashes involving motorcycles.

132 motorcyclist died on Washington roadways and of these we have driver information for 118.

You'll see that information here.

So when we look into the records of those 118, we find 50% of those writers a full 59 of these writers were not endorsed.

It's about a 10% increase from the unendorsed ridership and involved in fatal crashes last year.

Of the remaining 59 writers.

19 had received their permit or endorsement since 2020, and of those, nine were fully endorsed.

That's this number here.

Umm, now this is incidental information, but it leads me to believe that our change in endorsement requirements may be having an impact, especially if you consider that a writer with a permit now is only at the same level as a writer who got their endorsement prior to 2020.

So, uh, real quick, 132 fatalities.

Of those, we know that nine of them received their full endorsement in the state of Washington after 2020, and everybody else was either unendorsed from another state.

So we don't have any records on them or had their endorsement or permit level tests from before 2020 or permit level test 2020 and beyond.

So this is fatalities in the county.

Uh, not, not writers from the county, but fatalities happening in the county.

Per capita, we're seeing a major shift here, showing that the numbers are writers dying versus the population of the county they died in.

And one of the reasons that this is, well, one of the things that this shows us is that writers are going to these locations that have the beautiful rides and and they also have low populations and they're becoming motorcycle fatalities there.

They were unfamiliar with the roads, they they don't know what to expect.

Only 19135 riders are crashes.

However, if you look on the right side of the screen, you're going to see that the general trend for fatal motorcycle crashes is trending up.

Umm to put it simply, motorcycles are crashing less but with more severe results as as I mentioned earlier, this trend has continued in 2022.

Uh, we had a 30 roughly 33% increase in fatal crashes between 21 and 22.

So what types of crashes are we seeing?

The top five collision types for motorcycle facilities are listed here.

This shows a comparison to all drivers involved in fatal crashes.

You'll notice these statistics are very are fairly similar across the board with just a few outliers.

For instance, 10% of motorcyclists are killed when another car turns left in front of them.

But the number of drivers killed in this sort of crashes is statistically 0.

You'll also see that vehicles going straight, hitting pedestrians, there's a lot of cars that hit pedestrians, killing pedestrians and statistically zero motorcycles doing that.

However, fixed objects are are still a a threat to motorcyclists and and those.

We do see some expected differences in young motorcyclists between the ages of 25 and 34, where it's approximately 1% more for motorcyclists dying in collisions.
