

Insurance carrier list

Testing locations shall carry insurance by a company that is authorized to do business within the state of Washington. These insurance requirements are in accordance with your Contract Agreement, which states:

“The insurance ... shall be issued by an insurance company(s) authorized to do business within the state of Washington and shall be maintained and in full force and effect for the term of this contract and as prescribed by RCW 46.82.310 for licensure”

Commercial schools, when submitting your Acord Certificate, make sure that the insurance carrier name is listed along with the NAIC number. Your Acord Certificate will need to be completed and signed by your agent. Incomplete certificates will be returned.

Public schools, when submitting the Acord Certificate have your insurance agent list the actual name of the insurance carrier. This is the official name that they are doing business under in Washington State. The NAIC number will need to be included. We need this information for verification with the Office of Insurance Commission.

Prior to submitting your Acord Certificate, contact your insurance agent for questions regarding your provider. All schools must submit a completed Acord Certificate with an insurance carrier that is authorized to do business in Washington.

If you are using a specialty insurance, also known as the surplus line, we will not be able to verify this with the Insurance Commission. Your agent will need to indicate that the carrier is a surplus line on the Acord Certificate. ***For specific questions about your insurance carrier please contact your insurance agent.***
