

## Vehicle/Vessel Refund Request

Use this form to apply for a refund of vehicle or vessel fees.

### Is there a time limit?

Yes, if your vehicle was sold/traded/destroyed/totaled after your registration was purchased. **We must receive your request BEFORE the registration period begins.** If you cannot mail your request (post marked before the registration period begins), fax this request and then **mail your request and documents the next business day.**
