Fingerprinting and background checks

You need a fingerprint-based background check:

- When applying for a new real estate broker license
- When applying for a managing broker license through reciprocity
- Every 6 years with your active real estate broker or managing broker license renewal

To get your fingerprints taken:

- **Inside Washington:** Go to <u>www.identogo.com</u> to schedule an appointment through our electronic fingerprinting vendor. You will pay IdentoGO for taking your fingerprints and for the background checks required for your license type.
- Outside Washington: Call (360) 664-6484 for fingerprint card submission instructions.
