

# Apply for an Appraisal Management Company License Online

# **Before You Begin**

- If you are a **Washington-based** Appraisal Management Company (AMC), you must get a UBI by registering with the Secretary of State. You will be issued a UBI when you file.
  - You must also register with the Department of Revenue for tax purposes.
- Each owner with 10% or more ownership of the business must submit fingerprints for a background check. See the <u>Fingerprinting and background</u> <u>checks</u> page on the Department of Licensing webpage for information on this process.
- The following forms must be completed, signed and dated, and ready for upload:
  - The Designated Controlling Person must complete the <u>AMC Designated</u> <u>Controlling Person Registration</u> form
  - o AMC \$100,000 Surety Bond
  - <u>AMC Appraisal Subcommittee National Registry of AMC's Eligibility</u> <u>Registration</u> form
  - <u>AMC Owner Registration</u> forms (one for each owner with at least 10% ownership of the business, signed and dated by the owner)
  - o <u>AMC Supplemental Ownership</u> form, listing all owners

#### **Start the Online Process**

- You must be in the **Chrome browser** and have **Chrome pop-up blockers turned OFF** to complete the application and pay.
- If you haven't already done so, create a SecureAccess Washington (SAW) account, add the Professional and Business Licensing service to your SAW account, and enroll in multi-factor authentication (MFA).
  - See <u>Create your user access</u> document for detailed instructions on creating your SAW account.
- To apply for a business license, you must have an existing Business Account OR create a new Business Account before you can apply for your AMC license.
  - If this is a new business with no other existing licenses, go to <u>Create a</u> <u>New Business Account</u> below.

- If you are adding an AMC license to a business account with other existing licenses and you haven't linked your business account, see <u>Create your</u> <u>user access</u> document for detailed instructions on linking an existing business account.
- If you already have linked the business account for the AMC license, go to Apply for the Appraisal Management Company License.

#### **Create a New Business Account**

- **1. Click** the Create Business Account button on the Home page.

  - **Out-of-state business:** Select AMC Outside WA from the Select an option dropdown. Go to step 3.
  - **Washington-based business:** Select Other Business from the Select an option dropdown.

- **5.** The system will validate your UBI against the Secretary of State website (for corporations or LLCs) or against the Department of Revenue website (for sole proprietors and partnerships).
  - Occasionally, the lookup for Secretary of State won't work properly. If you
    get an error message for a Corporation or LLC and you know you have an
    Active registration with Secretary of State, change your business structure
    to Sole Proprietor and click Validate UBI. This will have the system check
    against Department of Revenue instead.
- **6.** The system will populate the Business Name field from the Secretary of State OR Department or Revenue website.

## Apply for the Appraisal Management Company License

- For Washington-based companies with a UBI, you'll need the Business ID and Location ID from your Business License issued by the Department of Revenue.
  - You can find these numbers on the Business License issued by the Department of Revenue OR by going to dor.wa.gov and selecting Look up a business. Search for your business by UBI number or business name.
  - Out-of-state companies DON'T need to enter this information.
