# Abandoned Recreational Vehicle (RV) Reimbursement Request

Registered tow truck operators (RTTO), wreckers, and motor vehicle scrap/salvage processors use this form **if you do not have access** to submit requests in your Abandoned Vehicle account or your Destroyed Vehicle account via license eXpress for business.

You can request reimbursement for costs related to the disposal of an RV. All abandoned RVs must first be handled through one of the following submitted to us:

- the abandoned vehicle process with an Abandoned Vehicle Report (AVR), or
- the junk vehicle process with a Junk Vehicle Affidavit (JVA)

#### You will need to acknowledge that the following statements are true

- RV was a public impound.
- RV was abandoned pursuant to RCW 46.55.
- Last registered owner is unknown after reasonable effort compliant with RCW 46.55.100.
- RV received no bids at auction.
- RV was declared an abandoned junk vehicle by law enforcement officer and towed from public property.

### In addition, you must include all the following documentation for your business type RTTOs

- Abandoned Vehicle Report with the Affidavit of Sale section completed or Junk Vehicle Affidavit with the Affidavit of Destruction section completed.
- Certificate of Fact indicating the tow truck vehicle class, hours of service, license plate number, and number of days stored if not already included on your invoice.
- Written record of delivery to a licensed dismantler or authorized disposal site. with the Abandoned Vehicle Report with the Affidavit of Sale section completed or Junk Vehicle Affidavit with the Affidavit of Destruction section completed.
- All receipts and invoices verifying costs accrued after 5/1/1019.
- Photos of RV type and vehicle measurements if no VIN is found or there is no Washington record.
- Impound authorization form the law enforcement officer requesting the tow must complete it.

#### Wreckers and motor vehicle scrap/salvage processors

- Abandoned Vehicle Report with the Affidavit of Sale section completed or Junk Vehicle Affidavit with the Affidavit of Destruction section completed.
- Certificate of Fact stating RV has been destroyed in a manner as to not be used as a vehicle again and the date of destruction.
- Wrecker/Salvage processor monthly report. Or, use your Destroyed Vehicle account in License eXpress to report the vehicle online.
- All receipts and invoices verifying costs accrued after 5/1/2019.
- Photos of RV type and vehicle measurements if no VIN is found or there is no Washington record.
